REFERENCE # IMP

Under Revenue Canada Customs regulations, you are required to inform Canada Customs of ALL GOODS that you are bringing into Canada. This includes everything that you had upon your arrival, those goods which you are clearing now and those goods which you intended to have shipped later.

Revenue Canada Customs requires that you complete this form in full; any missing or incomplete information may result in delaying in the release of your goods. Revenue Canada Customs also reserves the right to examine any goods which are entering Canada.
